If we have not been able to contact you by then, we will proceed to take legal action and turn your pet over to the proper authorities.

### **📌 Signature**

By signing below, you authorize the above procedures and agree to pay when you pick up your pet (unless *prior* arrangements are made). Past due accounts will be charged a monthly fee of 1½% or \$4.50, whichever is greater. Delinquent accounts are turned over to our collection agency and incur a fee of 67% of the balance owing, plus a reasonable attorney's fee, if required.
